<p>Challenge</p> 	<p>Philadelphia College of Pharmacy at the USciences wanted to improve student success by operationalizing an assessment process to use data in more meaningful ways:</p> <ul style="list-style-type: none"> ■ Lack of transparency with student progress in meeting and exceeding outcomes expected of them by the pharmacy profession to impact patient health and save lives ■ Implementation of a new competency-driven curriculum, which required more data and decisions made in real-time ■ Accreditation visit looming! ■ Recently appointed Director of Assessment
<p>Solution</p> 	<p>In just 18-months, following the adoption of AEFIS end-to-end assessment management platform, we were successful in operationalizing assessment processes and moreover providing students and faculty access to evidence of learning and skills recognition through the CLR. <p>Outcomes</p> 	<p>The success of this implementation is proof that this model can work in the field, have a direct impact on student success, and can be achieved in short timelines with modest resources. We are confident this approach serves as an evolutionary pathway to institutions, large and small, who want to create meaningful value from assessment while igniting transparency and shared agency for student success.
